Fund Description

AXTX provides 2x exposure, less fees and expenses, to the daily price movement of AXT, Inc. (AXTI). AXT, Inc. is a semiconductor materials company that develops and manufactures compound semiconductor wafer substrates such as indium phosphide, gallium arsenide, and germanium for telecom, data center, and optoelectronic applications.

FactSet Analyst Report

AXTX is a short-term tactical tool that aims to deliver twice (200%) the daily performance of AXT, Inc. (AXTI), before fees and expenses. The fund primarily enters into total return swap agreements with major global financial institutions that mirror AXTI's daily returns. In case swaps are unavailable or less efficient, the fund may use FLEX call options or directly hold AXTI stock. Purchasers holding shares for longer than a day will need to monitor and rebalance their position frequently to attempt to achieve the 2x multiple. Purchasers should conduct their own individual stock research prior to initiating a position and trade with conviction. Due to the complexities of the product, shares tend to perform as anticipated only when the underlying shares are trending, and holders are on the positive corresponding side of that trade. The remaining cash is invested in collaterals such as US Treasuries, money market funds, or short-term corporate debt.
