LifeX 2048 Longevity Income ETF

Fund Description

LFAE actively manages US Treasury exposure, aiming to provide predictable cashflows through 2048. The fund is designed to appeal to investors born in 1948 and reaching age 100.

FactSet Analyst Report

The security is being delisted. The last day of trading on an exchange is September 15, 2025. LFAE targets monthly distributions of income and principal through the end of 2048, less operating fees. Managing US Treasury securities, a distribution rate is calculated based on the life expectancy of individuals born in 1948. In April 2028, the distribution rate is recalibrated, reducing payouts and rebalancing the portfolio to mitigate interest rate changes. At this time, shareholders turning 80 can choose between Longevity-Linked Distributions through a closed-end fund, offering monthly payments for life up to age 100, or Term Distributions, with monthly payouts continuing through 2048, or a combination of both. Both the Fund and closed-end funds will liquidate by 2048, distributing all assets and ceasing distributions. Distributions are typically on the 3rd business day of each month. A portion of each monthly distribution is considered return capital, reducing the amount for investment and lowering the investor's tax basis in their shares. Before February 7, 2025, the fund utilized Stone Ridge for branding instead of LifeX.
