Fund Description

TSII seeks to provide weekly distributions through a synthetic covered call strategy on Tesla (TSLA), while also aiming for 105% to 150% of TSLA's daily share price performance. The actively managed fund uses both standardized exchange-traded and FLEX options, collateralized by US treasuries.

FactSet Analyst Report

TSII offers weekly distributions and leveraged exposure to the daily price movements of Tesla (TSLA). The fund targets a 105% to 150% daily notional exposure to TSLA, utilizing a combination of deep in-the-money and at-the-money call and put options, swaps, and TSLA shares. Positions are rebalanced daily to maintain target leverage based on technical signals and real-time market sentiment. The strategy employs a covered call approach, writing out-of-the-money calls to generate income, thereby capping potential gains. Due to daily compounding and rebalancing, performance may differ significantly from TSLA over periods longer than one day. Note that the fund's use of leverage introduces increased volatility and risk. TSII does not provide direct ownership of TSLA shares and, therefore, does not have voting or dividend rights. Investments include US treasuries and money market funds as collateral.
